D&AR Case.



In terms of Para 533 of IRMM the competent authority to conduct Medical Examination of Non-Gazetted employees for promotion to Gazetted post is CMS or MS in-charge of the Division. Only those who qualify in the Medical Examination are eligible to attend Viva-Voce as per Railway Board's Lr.No.E(GP)80/2/8 dated 31.10.91.

The APARs in original in favour of the employees as listed in **Annexure "A "** for last five years with acknowledgement for having served the APARs to the employees and no further appeal pending for the same, should be sent to the undersigned on or before **24.03.2023**.
