In case of any change in the station/unit in which the employee working, the relieving/identification slip should be issued by the controlling officer in the office in which the employee is presently working.

In terms of Board's letter No. 79-E(SCT) 15/98 dated 18/12/1981 and No. 87-E(SCT)1/31/5 dated 02/12/1987, community certificate of Reserved community employees should be verified, particularly at the stage when the candidates are to be considered for promotion to the next higher grade.

It is therefore requested that the genuineness of the Community Certificate of reserved community employees may be verified and certified by the cadre controlling Personnel Officer and the attested copy of the **Community certificate** may be forwarded to this office, in case not submitted earlier.

There is no Pre Promotional Training (PPT) as all the vacancies are earmarked for UR.

The written examination is scheduled to be held on 29.04.2023 (Saturday) from 14.00 hrs. to 16.00 hrs. at Personnel Department Multipurpose Meeting Hall ,1st Floor, Headquarters Office, Southern Railway, Chennai-03

The employees in Annexure – “A” may be directed to appear for the written examination on the above date and venue.

The employees may be notified that they will be permitted to appear for the supplementary written examination only, on the following reasons:-

- 1) Those who could not be relieved due to Administrative Reason (or)
- 2) Sickness of the employee supported by Railway Medical certificate (or)
- 3) Any other reason which is beyond the control of the employee.

An identification slip (**as per Annexure “C”**) for the employees who are attending the written examination should be issued duly furnishing their photo, specimen signature and attested by their immediate supervisor/officer. The employees should produce the same at the time of the written examination, without which he/she will not be admitted to write the examination.
